Diver statement:

- I understand that diving with oxygen/helium enriched gasses poses certain risks of oxygen toxicity/hypoxia and/or improper mixtures of breathing gas. Also, I understand that the usual inherent risks of scuba diving; including, but not limited to decompression sickness, air embolism, drowning, or other injuries; may occur that require treatment in a recompression chamber or other medical facility. I understand that diving excursions may occur at a site that is remote, either by time or distance or both, from such a recompression chamber or medical facility. I still choose to proceed with such dives

in spite of the possible absence of a recompression chamber or medical facility in proximity to the dive site.

- I am aware of the risks and hazards associated with technical scuba diving. Mixed gas diving is an exciting and demanding activity. When performed correctly and correct techniques are applied, it is safe. When established safety procedures are not followed, however there are dangers. Diving can be strenuous under certain conditions. I am not extremely overweight or out of condition. My respiratory and circulatory systems and all body air spaces are normal and healthy. I understand that a person with heart trouble, current cold or congestion, epilepsy, asthma or other respiratory difficulties or other medical problems, or a person under the influence of medications or alcohol should not dive. I am in good health now and have no knowledge of the above or any other medical problem which might impair my safety while diving.
- I agree to not only pay in full for services rendered to me personally (rental, gas and other fees), but also to share costs incurred by my instructor(s)/assistant(s) or guide(s). These charges are divided equally between members of the party/group I was with during the time services were rendered to me. The amount of these charges is determined according to the latest published price list subject to change without prior notice.
- In consideration for being permitted to use equipment, transportation or services provided by Caribbean Gas Training B.V. and Bonaire Eco Experience N.V., I personally assume all risks of loss, injury or harm that may befall me in conjunction with use of said equipment, transportation or services and agree to take full responsibility for my own actions and safety.
- Furthermore, I agree to save and hold harmless Caribbean Gas Training B.V. and Bonaire Eco Experience N.V., their officers, employees and agents from any claim by me, my family, estate, heirs, or assigns arising directly or indirectly out of my use of equipment, transportation or services supplied by Caribbean Gas Training B.V. and Bonaire Eco Experience N.V.
- Additionally I agree to save and hold harmless the owner of the building, the land and the pier that are used by Caribbean Gas Training B.V. for its business, from any claim by me, my family, estate or assignees arising directly or indirectly from the use of that building and/or pier.
- I understand that I can take dive tanks onto boats that do not belong to Caribbean Gas Training B.V. only after explicit consent for this has been given to me. Tanks from Caribbean Gas Training B.V. may only be filled by Caribbean Gas Training B.V. personnel and equipment. I furthermore understand that every tank that leaves the facilities of Caribbean Gas Training B.V. needs to be analyzed for oxygen/helium content by myself or under my direct supervision.
- I agree to abide by the diving regulations set forth by Caribbean Gas Training B.V. as well as the Bonaire Marine Park; in particular, I understand that all reef areas, corals, fish, shells and other organisms as well as any artifacts around the territory of Bonaire are fully protected by law. I understand that it is a criminal offence to deface, destroy, pollute, injure, molest or remove from the water any reef, reef organism (living or death) or artifact and that failure to comply with such laws may result in imprisonment, fines and/or expulsion from Bonaire.
- If I rent, purchase or borrow any equipment from Caribbean Gas Training B.V., I agree to examine it and use it only if I find it to be in safe condition and good working order. I agree that I personally will use any equipment or gas rented, purchased or borrowed by me only for its intended purpose, and not rent, give or loan it to others. I agree to pay full replacement value of any rented or borrowed items in case of loss or damage as well as any losses which Caribbean Gas Training B.V. may suffer as a consequence of my actions.
- I accept that in case of differences of opinion, Netherlands Antilles law be exclusively the applicable law and the Court in Bonaire to be exclusively competent to decide legal disputes.
- Finally, I state that I have carefully read and understand the contents of this statement, that I understand that the terms are contractual and not a mere recital and that I am of lawful age and legally competent to sign this statement and release, and that I am signing of my own free will and agree to be bound by its terms.
